The wishes of the residents need to be respected by Melton Borough Council. Site two is an area of natural beauty with wildlife and migrating wildlife living within the area and at the present remains as usable farmland. The area is most certainly prone to flooding. Indeed when people came out to inspect the site, sheep were standing in water. If the site is built upon the flood plain that can no longer absorb water will cause problems to further areas within the village. Cars parked in this flood area will have oil washed from them into the surface water which will then be washed into the river. The bus service is not regular within the village so new home owners will require a car or several cars. Therefore the site will cause great pressure to the existing parking and traffic problems along Water Lane which then feed into the remainder of the village. People within the village have already stated they do do want further houses along Water Lane and have put this into our own local village plan.
