Notice is hereby given, in accordance with regulation 22(3) of the Town and Country Planning (Local Planning) (England) Regulations 2012, that Melton Borough Council has submitted the Melton Local Plan to the Secretary of State for Communities and Local Government on 4th October, 2017 for independent examination.

The Melton Local Plan will now be subjected to independent Examination to be conducted by a Planning Inspector from PINS (the Planning Inspectorate). This is a continuous process running from the date of submission through to the receipt of the appointed Planning Inspector's Report. Part of this process will involve hearing sessions where those invited to attend will have the opportunity to respond to matters raised by the appointed Planning Inspector. Please note invitation to participate is coordinated through the Planning Inspector and the Programme Officer, both of whom are independent from Melton Borough Council.
